## ANZ Inter-School Archery - Postal Shoot Rules 2012

### Introduction

Starting in 2010, Archery New Zealand (ANZ) sanctioned an Inter-School postal event for secondary and Intermediate schools. The purpose of this event is to allow schools throughout the country, regardless of location, to compete against one another.

If you are a school who has not done archery before, please contact Archery New Zealand ([jama@archerynz.co.nz](mailto:jama@archerynz.co.nz)) to receive information on what is required for starting up archery as a sport in your school.

### Rules and Regulations

- Four postal shoots shall be run per year, one in each term.
- Students of any New Zealand school may compete, in the divisions of intermediate (years 7-8) and secondary (years 9-13)
- The round may be shot as many times as desired during the allotted time frame. The highest score per archer shall be submitted by the school archery coordinator to [jama@archerynz.co.nz](mailto:jama@archerynz.co.nz) by the indicated date, using the results template which will be supplied.
- There are three bow divisions: Limited Recurve, Competition Recurve and Competition Compound. **Limited Recurve** consists of Recurve bows of <25#, simple tape and pin sights, no clickers, competition sights, pressure buttons or stabilisers. **Competition Recurve and Compound equipment** shall be as per FITA (International Archery Federation) rules.
- Archers may compete individually in any division, and also as teams.
- The top three scoring archers from each school, **shooting Limited Recurve only** shall comprise the school's A Team for that term. The next three shall comprise the B Team, and the next three shall comprise the C team. There is no limit on the number of entries of teams.
- Scoring must be undertaken on official scoresheets, which will be made available as a PDF.
- All scoresheets must be fully completed and signed.
- In the event of ties, the archer with the most combined 10s and Xs is the winner. If still a tie, the archer with the most Xs is the winner. If both have the same number of Xs, the result shall be a tie.
- In order to count, the postal shoot must be officiated over by a teacher-in-charge, or senior archery club member.

### Postal Round Description

- The shoot consists of 18 arrows at 15m (6 ends, 3 arrows per end).
- Limited Recurve shoot on an 80cm target face
- Competition Recurve shoot on a 60cm target face
- Competition Compound shoot on a 40cm target face
- All rounds are 10-zone scoring
- There shall be two 3-arrow sighting ends prior to scoring.
- There is no time limit.
- Other than the rules stated above, FITA rules shall apply.

### Results and Awards

Results shall be published at the end of each term. Certificates shall be awarded to 1st, 2nd and 3rd places in each of the three individual divisions, and a trophy awarded for the team results, (this is to be held by the winning school until the following terms winning team is decided).

### Entries

If your school wishes to compete in the Postal Event, please contact [jama@archerynz.co.nz](mailto:jama@archerynz.co.nz) and fill in the entry form which will be supplied. The entry fee for the postal shoot is \$1 per archer/per bow type/per term. ie An archer may compete as an limited and Competition Recurve provided the rules on whats on the bow are followed.
