- **Linda Jones (wife of Les Jones):** Whilst not a member of Archery NZ, Linda provided outstanding support for Les throughout his Archery involvement.
- **Eric Verlaguet:** Eric was Former president of Olympique Nouméa Natation, then vice-president of the League and vice-president of CTOS, and a member of the Dumbéa Archerie Club.

4 Minutes from the 2019 AGM

4.1 The 2019 AGM minutes were presented for approval.

It was <u>moved</u> by Cushla Matheson and seconded by Peter Russell that the minutes of the Archery NZ AGM 2019 meeting be approved as a true and correct record of the meeting. **Carried**

There were no matters arising from the minutes.

5 Annual Reports

5.1 Presidents Report

Colin spoke briefly to the Annual Report.

It was **moved** from the chair and seconded by Sier Vermunt that the Annual report 2019 be accepted.

Matters Arising:

It was noted that there is a mistake in the Selection Convenors Report. The Trans-Tasman Event was last won in 2012 in Rotorua not 2008 as stated.

6 Financial Report

General Manager Phil Vyver spoke to the Audited Accounts and outlined the key variations to the previous financial year. The budget for 2020-2021 was also tabled for discussion. A number of questions were then asked from the floor:

- Distribution of High Performance Funding: It was stated that the exact distribution of funding between disciplines has not been analysed. In general terms depending on the year and the events being held funding support will fluctuate slightly from discipline to discipline. With the Olympics approaching Recurve has been a greater focus in recent time.
- Funding: Planning and update of Strategic Plan will provide funders with the information they require to have confidence in the future of the organisation and sport and therefore be more likely to approve funding. Ongoing battle however to secure the required funds.
- Current FY: The lack of information in the report on the current financial year as noted. The is as a result of the AGM being so long after the end of the previous year and the requirement to publish a budget for the following FY. This will improve with the AGM moving to Oct/Nov each year.
- Funding support / alternative income: Looking at 3 main areas for support. Government, Community Trusts and Gaming Trusts, plus increasing sponsorship. Government funding from Sport NZ is likely to continue but the amount for the next 4 years won't be known until around April. This will all be for youth based support.
- Contract Fees it was noted that the audited accounts show contract fees for 1 contract for a part of the year, whilst the budget shows 2 contracts for a full 12 months hence the difference in amounts.
- Membership Fees It was noted that there has been a small decline in membership numbers over the past 12 months. The dollars received will be in line with budget expectations.

It was moved by the Chair and seconded by Kelly Atkinson that the Audited Accounts for 2019 and the Budget for 2020-2021 be approved. **Carried.**

7 Membership Fees

• No fee increase was proposed and the fees will therefore remain the same for a further season.

Les has had many roles within Archery New Zealand since 1997, namely coaching convenor, judge convenor, international judge candidate, continental judge, writer of articles for The Archer and so on. But perhaps the most important role that Les has undertaken is that of mentor and educator. Les has unstintingly given his time to engage with archers throughout New Zealand to enhance the outcomes of Archery. Les's recent retirement from archery has been received with much regret especially from those who have been recipients of Les's advice and support.

A vote was taken via show of hands and the meeting agreed to accept Les's nomination and to grant Life Membership for Archery NZ.

Karen Moffatt-McLeod then took over the running of the meeting and asked Patron, Bernie Fraser to present Colin Mitchell with Life Membership.

Colin Mitchell

2018 president then chair of Archery NZ; 2003 to 2004 – Vice President; 2003 (late) to 2009 – President; 2017 (late) to 2019 – President; 2019 to 2020 – Chair of the Board; 2003 to present - Archery NZ Judge; 2017 to 2018 – Judges' Commission Convenor; 1997 to present - Member of Rosebank Archery Club; 1999 to present – President Rosebank Archery Club.

Colin became involved on a national scale with roles as manager to several travelling teams to the Oceania Championships, and as a representative archer to Samoa in 2006. He was also asked to travel to Fiji to give advice to the Fijian archery team prior to the Pacific Games in 2003. Since 2003 Colin has been a National Judge travelling throughout New Zealand on a regular basis to tournaments, and briefly a World Archery Continental Judge Candidate which led to the opportunity to judge at the 2007 South Pacific Games in Samoa. In recent years he has been the Technical Director &/or Chief Judge for a number of National Championship tournaments, including the Trans Tasman Events in 2016 and 2019.

A vote was taken via show of hands and the meeting agreed to accept Colin's nomination and to grant Life Membership for Archery NZ.

A round of applause was given to Les and Colin.

9 General Business

The meeting was opened to general business:

9.1 Archery OSA

GM Phil Vyver outlined a plan to provide further investment and support for the development of Archery OSA (Steve Clifton). The idea being to make it the central point for all tournaments and results to allow for real time updating of results, records and rankings.

Discussion was held and it was agreed that further work needs to be done to ensure that Archery NZ retains some form of ownership so that any data collected is not lost and that the IP is protected. It was agreed that the Board needs to have further discussions with Steve before progressing.

12.2 **Outdoor Nationals**

Christchurch Archery Club has submitted a remit requesting that the Outdoor Target Nationals be held back in the first week of January. This was discussed by those present. It was agreed that there is no easy solution and that no time of year will be suitable for everyone. Following discussion it was agreed that the Board be given the flexibility to consider dates based on the overall needs of the archery community and the wider world archery calendar.


Phil Vyver noted that a plan is in place to develop a 2-4 year calendar of events to allow for better planning of all national competitions.

Personal Statement from the Chair

Sport exists to celebrate, mirror, and elevate the human spirit.

In taking on the role of chair, my personal goals were:

- to ensure that archery continues to be a sport that is accessible to everyone who wishes to participate whatever their capacity and aspiration.
- to engender respect for all people at all levels of the sport.
- to foster a celebration of hard work and achievement.
- to build a partnership with Māori through Ti Tiriti o Waitangi.
- to celebrate cultural and ethnic diversity and gender equality.

Some progress has been made towards creating an environment where kindness, compassion, fun and generosity are the primary outcomes but there is still a long way to go to achieve this. Every member of Archery New Zealand has a role to play in developing a positive and affirming culture for our sport.

Some small degree of progress has been made in addressing the shortcomings of our partnership with Ti Tiriti o Waitangi but the journey has begun. Mā whero, mā pango, ka oti te mahi.

The board is proud of having consistently exceeded the Sport NZ gender equity in governance criteria.

Having been involved in archery for a relatively short time but having attended many tournaments locally, regionally, and internationally, I have had the privilege of speaking to many current and past members. I have been concerned that many highly capable, skilled, and passionate people say they do not wish to be involved with the leadership of the sport because of past bad experiences. With a view to changing this, I have endeavoured to build an organization where these members would not only feel welcome to come back but also safe in the knowledge that any contribution they might subsequently make would be respected, honoured, and valued by everyone.

Some progress has been made but I am still not able to promise, should someone choose to return to a leadership role within the sport, that they will be safe from bullying, harassment, intimidation and attacks from within. This is an ongoing unresolved issue as recent events have shown, and clearly, while we have made some progress, we still have a long way to go before we can say we have ticked that box. The board apologises for its past shortcomings,

but it is the responsibility of each and every one of us to call out this behaviour when we see it and to use the Archery New Zealand Disputes and Discipline policy and processes to address it.

It will take courage, but I believe we can do it.

You are not alone.

Health, Safety and Wellbeing

Early in 2020 the board appointed Dr George Corbett, a health and safety expert, to the voluntary role of health, safety, and well-being advisor. This role has been created to support clubs and the board in ensuring that competitions are held in line with current legislation and, in a broader sense, oversee the well-being of all members. Dr Corbett was, for many years, a lecturer in health and safety at United Institute of Technology and is a welcome addition to the human expertise available to the organisation.

Member Protection and Safety

It's fair to say that Archery New Zealand has, for many years, been affected by culture of bullying, intimidation and harassment.

Recently, the board has adopted an updated Disputes and Disciplinary Policy which addresses the sequential nature of bullying and harassment which happen, not in a single instance, but over a protracted period of time. As an incorporated society, Archery New Zealand is member driven and it is the responsibility of each and every one of us to ensure the culture of the organisation is healthy and that all members are protected. While the board has a role to play in this it is not the exclusive role of the board to call out bullying and harassment. I would suggest that this is a role of all members and, while I acknowledge that

this can be extremely difficult for fear of becoming the next target, please don't hesitate to report instances that you see to the board who will enable the independent complaints committee to investigate. This can, of course, be done anonymously if you wish. Remember, you are not alone.

Sport NZ has engaged the Sport and Recreation Complaints and Mediation Service (SRCMS) to enable members to resolve concerns. Details can be found on the Sport NZ website.

Archery New Zealand (Inc) Restructure

In February 2000 the newly elected board met to discuss a proposed operational restructure. Concern had been expressed by past board members that there was a gap between enacting our governance responsibilities and, at the same time, overseeing some form of interconnected operational capacity.

In other words, it was hard to walk the talk.

The board agreed to establish a layer of subcommittees below the board but reporting to it, to ensure that the operational goals outlined in the Strategic Plan could be carried out. It was agreed that the subcommittees would be connected by a Terms of Reference framework and would report to the board monthly on their activities with these reports becoming agenda items for subsequent monthly board meetings.

It was not intended that all subcommittees would be ongoing as some might only be established to address a short-term, contemporary issues. Some however, it was agreed, would more than likely become permanent.

In addition to these subcommittees an Events Advisory Group led by Andrew Russell was created to ensure continuity of our national tournaments and events and the retention of the skills and experience necessary to maintain these. Andrew has developed a bidding process to ensure fairness and professionalism.

Subcommittee External Members

One of the primary strengths of the re-structure is that the board can now invite members who bring passion and experience in specialist areas onto subcommittees even though they are not elected or appointed board members. The subcommittee structure has enabled the board to gain expert advice and wisdom from its own members and this is seen as a significant strength.

Archery New Zealand Constitution

Work has begun on creating a new, built-for-purpose constitution. This has, to some extent, been forced on us by the government's clear intention to update the Incorporated Societies Act (1908) which has been the overarching legislation for incorporated societies for well over 100 years. There have been significant societal changes since its inception and the

legislation has become decidedly clunky. The New Zealand Law Society has proposed excellent recommendations to government and Archery New Zealand has worked within these recommendations to best fulfil the goals of Archery New Zealand as laid out in the Strategic Plan.

This work was begun by Dr Sier Vermunt in early 2020 and was, on his subsequent resignation, picked up by the Chair of the Governance subcommittee Andrew Russell.

The board is extremely grateful for input from the Life Members in particular Carole Hicks MNZM whose expertise and recommendations were of great value.

Ti Tiriti o Waitangi

Archery New Zealand has responsibilities under Ti Tiriti o Waitangi and the board is currently exploring better ways to engage in this partnership. Sport NZ has expectations around inclusion and equity and Archery New Zealand has willingly embarked on this journey.

Board Meetings

There has been a calculated change in the Archery New Zealand culture regarding meetings. In the past meetings have been face-to-face and mostly in Auckland. The cost associated with this has been significant with these meetings often lasting up to two days. Early in 2020 the board determined to meet online to ensure that savings could be made. Board meetings are held once a month. Subcommittee meetings happen in the week prior to full board meetings to enable reports to be available in time for full board meetings. This has been an excellent cost saving and board meetings now seldom last more than two and a half hours. The saving of time and personal energy has also been significant.

Electronic AGM Meetings

The board is conscious that, in a modern world, it is essential that meetings such as AGM and SGM can be accessed online. There are challenges and the board is currently exploring ways to ensure that this capacity will be available in the future. This will be an important feature of the new Constitution.

Fiscal Prudence

Archery New Zealand's financial policy is based on fiscal prudence and fiduciary responsibility. Rather than appoint a board member as treasurer, the restructure created a Finance and Risk subcommittee designed to take ongoing responsibility for these critical

areas and to report recommendations to the board. Archery New Zealand has been fortunate to entice members with specific expertise to guide this subcommittee. Special thanks to Grant Hewson who has taken the lead and to Elizabeth Elkins, Chris Wilson, Mike Thompson and especially to Anne Mitchell for her ongoing wisdom and service.

Rules & Regulations Review

As part of the ongoing Archery New Zealand Strategic Review, the board has begun an extensive assessment of our Rules, Regulations and Policies. Many of these are of long-standing and have served us well but need to be revised to ensure that they are not contradictory, at odds with the proposed new Constitution, and that they support the strategic direction for the organisation. It is critical that policies turn into practices that benefit members. This review is still in its early stages and is being led by Andrew Russell.

Services to Clubs and Members

The work of the board is driven by a desire to provide the best service possible to clubs and members and to this end the board is investigating opportunities around collective insurance for clubs. As a result of a survey undertaken by the General Manager in 2020, ongoing concerns about police checks for coaches and others working with children have been identified. The importance of this cannot be over-estimated as it provides a degree of protection and comfort for both our young people and for our coaches.

COVID 19

COVID-19 has created severe uncertainty for Archery New Zealand but, while the organisation has largely dealt well with the challenges, there have been scars left on clubs and membership has been affected. Fortunately, the board has been wisely guided throughout initially by then board member Dr Sier Vermunt and throughout by Sport NZ, the New Zealand Olympic Committee and the government. Archery New Zealand has enabled members to remain informed and to keep safe while, Alert Levels permitting, continuing to shoot. Special thanks to Auckland Archery Club for sharing its excellent COVID-19 protocols and for allowing Archery New Zealand to share them with clubs that were struggling to keep functioning and their members safe.

Early in 2020 athletes had competed successfully at the Sydney Indoor Archery Festival and others were off at the Chula Vista Olympic Training Centre in the US for a multi-country pre-Olympic Training Camp. The Archery New Zealand Development Team had competed in Bangkok 2020 Asia Cup Leg One and managed to return home safely as things became

increasingly uncertain. Thanks Karen Moffatt-McLeod who facilitated this exciting opportunity for our young athletes and to the officials who got them home safely. There remained an air of excited expectation around the scheduled World Archery Oceania Tournament in Fiji and many had made flight and accommodation bookings.

Then COVID-19 hit.

As the shadow of the virus loomed, we were fortunate to have excellent counsel from board member and medical professional Dr Sier Vermunt along with exceptional contacts within the Fiji government who warned of the imminent border closure. This enabled the board to make an early decision not to send a team to this tournament which, while it affected everyone selected, it was especially harsh for those who had been selected to represent their country for the first time.

It's been a disrupted year and COVID-19 may have affected the numbers participating in this year's National Championships. Congratulations to everyone who has made it to Hamilton. We hope you have a fantastic week.

Relief Packages

Archery New Zealand is grateful for the government's relief packages that have enabled Sport New Zealand to continue with funding and for our organisation to take only a minor hit.



Communication

Archery New Zealand has worked to find new and effective ways to communicate with members through newsletters, social media and the Archery New Zealand website. Feedback regarding the newsletter has been positive and seen as an additional way for members to stay in touch with activities happening throughout the country and at all levels of the sport. Thanks to Lisa for her work on this and to clubs for keeping the content flowing.

Facebook continues to be the most direct way of connecting with members and the board invites contributions from members who have a story to tell.

Surveys & Consultation

A primary responsibility of the Archery New Zealand board is to ensure that the channels of communication between the membership and those tasked with its governance are open and available. To this end there has been an increasing degree of consultation with members through opinion surveys, online seminars, and an openness to be available for dialogue.

Over recent years there has been considerable discussion regarding Selection Policy and the survey from early in 2020 provided the board with a number of good options that have already been implemented.

Social Media

Social media can be a powerful communication tool when used appropriately. When in doubt about what you may safely post please check the Archery New Zealand Member Protection Policy which gives clear guidelines as to what is acceptable and what is not.

Facebook remains a primary means of communication with analytics showing that upwards of 3,000 visitors engaging each week. Archery New Zealand regularly posts material 3 to 3.5 times a week.

Archery OSA

Archery OSA has been used increasingly as a means whereby members can be kept informed about tournaments, events, and as a means of promoting and registering for online and in person training opportunities.



Volunteers

Archery New Zealand is reliant on the work of willing volunteers and we are fortunate to have a number who work tirelessly for the organisation. We call then the 'Admin Elves'. Without them Archery New Zealand would not be able to function effectively at all. Feel free to offer yourself as a volunteer at the conclusion of the meeting – and say thanks to those who continue to work diligently for the betterment of our sport.

Eleven of the participants successfully completed the requirements of the World Archery Level 2 coaching course and were additionally credited as Archery New Zealand Performances coaches.

Archery for Young People

Due to popular demand the Archery for Young People subcommittee reinstituted the young people's incentive programme and have made it more accessible to all.

Postal shoots have been expanded and are increasingly well supported.

Jeanette Franklyn and her team did a magnificent job with the College Sport Auckland weekly archery tournament and finals day despite losing a week to COVID-19. The sight of 150+ young archers and their support crews from a wide range of Auckland secondary schools shooting at Cornwall Park was magnificent.

2020 Tokyo Olympics

The on again off-again Olympics have presented challenges to Archery New Zealand on almost every level but compared with other sports and the New Zealand Olympic Committee itself our challenges have been minor. We are a small country with slender resources when it comes to mega events and it is to the credit of our athletes that they have kept training and never given up.

The primary challenge for Archery New Zealand is that the board has no role to play in the nomination and selection of athletes who we consider capable of representing our country at this keynote event. The process is:

- the board appoints the selection panel and the selection panel, independent of the board, makes its nomination to the New Zealand Olympic committee.
- The NZ Olympic committee determine which athletes will make the final cut and this can be a brutal process.
- The New Zealand Olympic committee remains adamant that athletes sent to Tokyo
 must have the potential to achieve a top 16 place and be trending towards top eight.
- This decision is out of both the board's and the selection panel's control.
- As there is still an opportunity for our shortlist athletes to achieve qualifying scores at the Nationals and I would ask that we all get behind them and support them fully.
- The board has, and will continue to, support them in every way we can.

Trans-Tasman Challenge

Our young athletes look forward to the Trans-Tasman Challenge and the next iteration of this is planned to occur this year in Australia. At present we have no information to share.

World Archery 2020 Hyundai World Cup Events

The board has determined, on health and safety grounds, not to select teams for any events between now and the end of August. This decision to participate internationally will be constantly under review.

World Archery 2021 Youth World Championships

World Archery 2021 Youth World Championships have been re-scheduled to take place in Wroclaw, Poland which has among the worst COVID-19 infection figures in the world. The board of Archery New Zealand has determined not to select a team for this event for health and safety reasons.

ACTIVE SPECIALIST PROJECTS

The Archery New Zealand Archive Project

The board has undertaken a project that will see an online archive developed that will record the history of archery in this country. This project is in the early days of planning and sourcing of funding. If you have shoeboxes full of photographs and memorabilia tucked away somewhere in your home, dust it off because at some point it may be photographed and find an additional home online.

The South Auckland Project

Working with CLM from Counties Manukau, events and school connections have been identified for archery experiences with a development pathway for new archers. The project is currently awaiting equipment to arrive from overseas.

World Archery Excellence Centre for Oceania

A working group is being established to complete scoping documents and a feasibility study for this project. Meetings have taken place in relation to two possible partnerships for shared spaces to host the Excellence Centre with enough land and space in each for both indoor and outdoor ranges.

Her work in the time that she has been General Manager has been exemplary both in its breadth and in the level of generosity that she has brought to her work. I would like to say a personal thank you to Lisa for her companionship, her compassion, and her capacity to go the extra mile.

It is also fair to say that we have lost other extraordinary people this year and this cannot be allowed to continue. It is up to each and every one of us to behave in ways that are respectful, kind and generous and it saddens me deeply to note that, in only a few cases, this has not been the case.

The organisation is seriously worse off because of it.

We must do better.

A MESSAGE FROM DR GEORGE CORBETT, HEALTH, SAFETY & WELL-BEING ADVISOR

It is with considerable concern that I write to you regarding a serious Health and Safety issue affecting the Executive of Archery NZ.

It is somewhat concerning to me that the only persons I can address this to are the Executive Team themselves, the very persons affected in this instance, but we have a "duty of care" to <u>all</u> our members which includes them.

For all my time that I have been Archery NZ's Health and Safety Advisor (2 years) I have been hearing of many instances of:

- · Bullying,
- Harassment,
- · Over-work,
- and constant complaints

directed at the board of the organisation.

The factors listed above are all well known, documented, causes of stress and that indicates that this is a serious Health and Safety issue that must be addressed as a matter of urgency to mitigate the risk to the health of the board of Archery NZ. This is NOT a safe environment for them to be in. In an employment environment immediate action would be required.

I have seen three (if we now count Lisa Walker), General Managers come and go, along with a constant stream of dedicated, and enthusiastic, Archery NZ Board Members, all of whom have cited extreme stress related to their role. I understand that the incumbent Chair of the Board, has lasted some 11 months which is reflected in her dedication to the role, all the rest of the Board have had much shorter tenures.

All the persons concerned with the smooth running of this organisation are volunteers, except for the General Manager, which has been a part-time paid role, and we all do this for the love of our sport.

With the Annual General Meeting upon us, the incoming Board, along with our members must address this issue and "take all practical steps" to mitigate the risk to our Board member's health.
