4.1 Online History

PROPOSAL: Online New Zealand Archery Archive.

It is hereby proposed that Archery New Zealand explore the creation of an online archery archive celebrating the sport of Archery in New Zealand.

It is envisaged that, in the first instance, this project will involve identifying a range of existing paper-based paper or similar documentation and other historic material that can be turned into an appropriate repository for a documentary history of archery in Aotearoa New Zealand.

It is also envisaged that a living oral history archive will be developed that includes filmed interviews with people who have been, and are, significant within our sport.

Should this proposal be adopted by the board it is possible that the first of these archival interviews could be recorded at the 2021 National Championships, a schedule to be immediately created should this proposal meet with the board's approval.

It is critical that Archery New Zealand (Inc) is a partner in this project.
