2.3 Administrator Recruitment

Seeking to obtain a part time administrator to fill this position (20 hours per week).

Suggestion that General Manager role be filled, in order for governance to be managed.

With Administration Manager role filled, it was discussed whether the part time role would be best filled by a GM or Administrator. Agreed that Andrew Russell would distribute role description to administrator to new Board members for review and further discussion.

Internal recruitment has not been successful in filling this position.

2.4 Constitution Review

53 individual member responses.

Feedback - changes to constitution, before AGM.

Noted that feedback from some clubs appeared that they believe this change was mandatory - the Governance committee is to respond to clubs confirming that becoming an Affiliated club is an optional.

Minutes: Board Meeting - 24 May 2022

Need to reintroduce a non-shooting membership fee and shooting membership type, particularly looking into fees. (Optional to clubs)

e.g. \$30 to \$35 for members shooting fee

e.g. \$10 - \$15 for non shooting members, similar to a donation

Need to address insurance issues around member feedback.

Constitution to be updated and disseminated before Electronic Ballot.

Craig McFarland - legal review - Maria Clark lawyer to get in contact with.
