- Perfect pin claims no longer need to be sighted by a judge we instead trust the signed scoresheets just like we do for all other score-related items.
- ANZ Merit Pins can be claimed at Minor Registered Shoots (with a senior club members officiating, rather than an ArcheryNZ Judge), however Merit Stars still need to be claimed at a major tournament (i.e with ANZ judges present)."
